“NATIONAL AWARDS FOR EXCELLENCE IN FORESTRY BY ICFRE”

2006-2008

Nominations/applications are invited for biannual ICFRE Awards for four “National Awards for Excellence in Forestry by ICFRE” for the period 2006-2008 on biannual basis. These Awards shall be given for original and outstanding notable work/research contribution in the fields of (a) Forest Education (b) Forest Research (c) Forest Extension.

One of the four awards called “Young Scientists Award in Forestry” shall be given only to the scientist with 40 years or less of age, with work preferably linked to the project(s) of ICFRE.

Each of the four Awards carries Rs.1,00,000/- (Rupees One lakh) and a certificate.

ELIGIBILITY

- (a) All Institutes, Workers (individuals and teams of Scientists) engaged in research in forestry wood and applied sciences and those concerned with the afforestation, forest conservation, protection and utilization etc. shall be eligible for the award.
- (b) The notable and original research work both fundamental and applied mentioned in books, monographs, papers, and other published accounts of outstanding research work, inventions and discoveries which contribute to the advancement of forestry, wood, and allied sciences shall qualify for the award. Meritorious work done in afforestation, forest protection, bio-diversity, forest conservation etc. shall qualify for award in the relevant field.
- (c) Indian citizens will be eligible for these awards.
- (d) An institution, team of scientists or individual once awarded for their/its work shall not be eligible for this award a second time.
- (e) The application or work once not accepted for grant of an award in a particular year shall not be considered in the subsequent years also.

PROCEDURE

Four sets of application separately for each category applied for in the prescribed Proforma enclosed as Annexure-1, complete in all respects, must reach the office of the Secretary, ICFRE, P.O. New Forest, Dehradun-248 006 on or before **28. 02. 2009**.

Individuals/Teams working under any organization must route their applications/nominations through proper channel. Each nomination/application should be accompanied by a detailed statement of work and attainments of the nominee or applications, as the case may be.

In case a nomination is received directly from a candidate, the authenticity of the work shall be verified by seeking comments of appropriate authority.

GENERAL

The performance shall be adjudged on the basis of the work done during the five years preceeding the year of Award. In case of jointly conducted work/research work adjudged fit for an Award, the amount of Award will be equally distributed among the awardees on the recommendation by the Assessing and Judging Committee. In the case of Institutions, the amount of award will be given to the Head of the Institution for utilizing the money for improvement in the discipline of the work which earned the Award. If none of the entries are found fit for the Award in any or all the disciplines, no award shall be given.

The selection made by the Council for these Awards shall be final and no appeal whatsoever, shall be entertained thereafter. Any canvassing would be treated as disqualification.
