Firms/Persons interested to buy the aforesaid vehicle are required to submit their highest quotation in the enclosed proforma, addressed to the Director, National Museum of Natural History, Room No. 407, 4th floor, Block No. 3, CGO, Complex, Lodhi Road, New Delhi:-110003 from 11.00AM to 3.30 PM by 15/11/2018. The sealed quotations/tenders received will be opened by the Tender/Purchase committee at 4.00 PM on the same day i.e. 15/11/2018. The vehicle is available for inspection from 11.00AM to 3.00 PM on all working days from 23/10/2018 to 14/11/2018 at Rajiv Gandhi Regional Museum of Natural History, (Ministry of Environment, Forest & Climate Change), Village Ram Singh Pura, Post Sherpur, Ranthambore Road, Sawaj Madhopur (Rajasthan).

3. The interested Bidders may submit their bid application alongwith an Earnest Money Deposit of Rs. 10,000/- (Rupees Ten thousand only) by way of Demand Draft/Pay Order in favour of "Pay & Accounts Officer" MoEF&CC, New Delhi. The quotations/tenders received without Earnest Money Deposit (EMD) will not be considered and shall not be accepted by this Ministry/Department.

4. The quotations received in time will be opened at National Museum of Natural History, Room No. 407, 4th floor, Block No. 3, CGO, Complex, Lodhi Road, New Delhi:-110003 at 4.00 PM on 15/11/2018. The Bidders or their representative (not more than one) may be present, if they so desire at the time of opening of quotations.

5. The auction will be governed by the following conditions:-
- (i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.10000/- within one week of opening of bids by of Demand Draft in favour of "Pay & Accounts Officer, MoEF&CC, New Delhi".
 - (ii) The delivery of the sold vehicle will be given only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card/Aadhar Card in case of Individual and Registration Certificate in case of firm etc.). The successful bidder has to take the delivery of vehicle from Rajiv Gandhi Regional Museum of Natural History (Ministry of Environment, Forest & Climate Change), Village Ram Singh Pura, Post Sherpur, Ranthambore Road, Sawai Madhopur (Rajasthan) at their own expenses.
 - (iii) Disputes, if any shall be subject to Jurisdiction in the Court of Delhi only.
 - (iv) The vehicle will be disposed off on "**as is where basis is**" and no guarantee for its worthiness or quality will be given by this Ministry/Department.
 - (v) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Ministry/Department will not be responsible for any lapse on his part in this regard. The Original Registration Certificate of the vehicle has been destroyed in the massive fire of NMNH Building. However a certificate will be provided to the successful bidder, which has been issued by the Transport Department.
 - (vi) The successful bidder shall not be allowed to withdraw his bid and in the event of his withdrawing from the bid, his earnest money will be forfeited.
 - (vii) The sold vehicle will be removed by the successful bidder(s) within 72 hours of depositing the balance money at their own expenses after that a penalty of Rs. 500/- per day will be charged. No assistance/ transportation will be provided by the Ministry/Department. Permission to take out the disposed vehicles from the premises will not be allowed on holidays, Saturday and Sunday etc.
 - (viii) G.S.T. @ 18% will have to be paid by the successful bidder/tenderer over and above his offer as per Government Rules.
 - (ix) Tender form should be signed in ink by the authorized signatory only. Photocopy of unsigned quotations/tenders or quotations/tenders not signed by the authorized signatory shall be rejected.
